You'll get a unique view into Scotland's rich history and gain valuable experience in the tourism industry and help bring Scotland's dramatic history to life for our visitors from across the world. Explore the fascinating stories from Scotland's past and share your passion with international and local visitors who come to Kildrummy Castle.

Based at Kildrummy Castle, you will prepare the site for visitors each day and welcome visitors to the site during the summer season. Assisting visitors with information and the most suitable tickets and products, you will make sure they have the best possible experience of this site with its rich history.

The wide variety of visitors to Kildrummy Castle makes this an interesting and varied role, with the opportunity to give guided tours to small groups of appreciative visitors.

You may also be asked to work from time to time no more than once a month - at Corgarff Castle, 20 miles away. Travel expenses will be paid for this and all other work travel.

Overview of the role and more about my team

This is an exciting opportunity to work for the lead body responsible for the historic environment in Scotland. Your role of Steward sits within the Grampian district, you will be actively involved in work which supports providing the best experience for our visitors – ranging from: greeting our visitors in the car park, carrying out cleaning and grounds maintenance duties, selling admission tickets or processing online bookings, selling our range of retail products or outlining the history of the site to our diverse visitor base. You will be part of a team of two stewards working in a monument, led by a Dual Monument Manager.

We are looking for someone who enjoys interacting with diverse groups of people, who has a passion for customer service and who would thrive in a fast-paced and constantly changing workplace.

You will work five days a week including public holidays, alongside the other Steward at this site, the Dual Monument Manager, colleagues from Corgarff Castle or on your own. You may also be asked to work from time to time at Corgarff Castle or other neighbouring sites in Grampian, and to attend training at other sites or locations in the Region.

What will my role involve and what will be my responsibilities?

Customer Service

- Process and promote retail and admissions transactions through the till system.
- Ensure a high standard of presentation throughout the site, following appropriate cleaning processes in both public and staff areas.
- Support the team in achievement of quality assurance Key Performance Indicators (KPIs).
- Actively support in HES seminars, events, functions and promotions.
- Provide the warmest welcome to our visitors and engage proactively with customer service.
- Deliver guided tours/talks as part of the core visitor experience.

Teamwork

- Proactively communicate with colleagues across the site to ensure high performance, standards and consistency.
- Support the Dual Monument Manager on partnership and community engagement initiatives and projects, including volunteering, weddings and other events.
- Carry out other appropriate duties requested by the Dual Monument Manager.

Commercial Awareness

- Work together with your monument team to achieve overall commercial performance targets.
- Promote commercial opportunities within the monument, such as upcoming events and retail products where appropriate.
- Assist the Dual Monument Manager to ensure accurate stock management and assist with stock ordering and deliveries as required.

Health and Safety & Compliance

- Ensure the security of the site, buildings and contents, including acting as key holder.
- Monitor and comply with all H&S procedures/guidance relevant to the site.
- Follow correct procedures to ensure safe operation of all equipment.
- Ensure that the health and safety of staff, visitors and contractors is paramount at all times.

- IT skills and ability to use basic online functions.
- An existing first aid qualification, or willingness to be trained in first aid.
