Thank you for your interest in the post of Inspection Lead with Historic Environment Scotland. This is a permanent and pensionable appointment.

The High Level Masonry Inspection (HLMI) Lead Inspector is responsible for delivering High Level Fabric Inspections from pre inspection stage to post inspection. Leading a small team of inspectors and a deputy carrying out tactile fabric inspections, which provide assurance on life safety risk across the HES estate of Properties in Care (PICs). Liaising and communicating with stakeholders to ensure inspections are carried out in a safe manner and in line with HES policy and procedures.

About us

We are the lead body for Scotland's historic environment; a charity dedicated to the advancement of heritage, culture, education and environmental protection. We're at the forefront of researching and understanding the historic environment, and addressing the impact of climate change on its future. Overview of the post and information about the team

The High Level Masonry Inspection (HLMI) Lead Inspector is responsible for delivery of High Level Fabric Inspections from beginning to end. Line managing a Deputy Inspection Lead, supervising a team of inspectors on site, ensuring that all relevant internal and external stakeholders are consulted and informed at the right stages of inspection. Responsible for ensuring health and safety due diligence has been carried out throughout the inspection process. Liaising with contractors and consultants as required, to ensure statutory and policy requirements are complied with.

The Lead Inspector is expected to work in a hybrid manner, with time spent carrying out research and desk-based activity, and time spent on site, leading site meetings and overseeing inspections. There will be a requirement to travel to site, and between sites across the entirety of the estate/country, with extended periods of time spent away from home on occasion. The work can be physically demanding, often spent on site in variable weather conditions. The work can also be mentally demanding, requiring detailed planning, reactive planning, and high volumes of tasks to prioritise/manage

High Level Masonry teams are typically structured as follows:

1 x Lead Inspector, 1 x Deputy Lead Inspector and 4 x Inspectors. They liaise closely with the HLM Programme Manager and an allocated CAD Technician/Building Conservation Technologist to ensure all inspection data is accurate and stored correctly. HLMI teams are tasked with delivery of our National HLMI programme across HES Properties in Care as a key corporate priority. Preparing to inspect, inspecting, and reporting of tactile inspection findings, on all built fabric above 1.5m across the HES estate.



Key responsibilities, duties and objectives

- Lead High Level Masonry Inspections across the whole lifecycle of inspection from pre inspection to reporting and debriefs.
- Manage a High Level Masonry Inspection team, with oversight on completion of inspections and reports to required standards.
- Contribute to the goals of the wider HLM Project, informing life safety risk and future repair requirements at PICs.
- Responsible for ensuring health and safety measures have been planned, followed and that due diligence has been carried out in accordance with regulations.
- Responsible for allocating tasks and inspection areas to inspectors, communicating progress to the National Lead and relevant stakeholders.
- You will bring strong people leadership and communication skills to the team, creating a culture that allows a strong team bond to develop.
- Work collaboratively across organisational boundaries, you will encourage your team to engage with HES's objectives and explore new opportunities for their development, assessing training requirements and arranging appropriate training.
- Role model a proactive, collaborative culture, encouraging your team to think beyond boundaries and work cross-Regionally to achieve the best outcomes for the organisation.
- Provide technical guidance and support to your team, or finding appropriate, timely solutions where you cannot
