As part of a multidisciplinary team, you will work with the Regional and District Works Managers within your Operations area to conserve and maintain the scheduled ancient monuments and ancillary buildings managed by HES on behalf of Scottish Ministers. Within your district, you will also work closely with the District Visitor and Community Managers as part of tactical local delivery and wider strategic priorities for the Operations Directorate.

Overview of the post and information about the team

The District Architect/Surveyor is a leadership role in our Operations Directorate. The Operations Directorate is a newly created Directorate that will strengthen our regional footprint and, for the first time bring together under one directorate, delivery of many of HES' activities at a regional and local level across Scotland.

Reporting to the Head of Region, you will support through conservation planning and practice the operational delivery of asset management activities across all Properties in Care, and scheduled monuments within the Region according to our corporate strategies, systems and policies.

You'll bring an in-depth knowledge of the unique requirements of undertaking property and conservation works to heritage assets and supporting infrastructure, working confidently as an expert in the conservation and repair of our assets and supporting the delivery of commercial operations, visitor experience and collections management.

You will collaborate in our operational leadership team with the Regional Visitor and Community Manager who leads on the delivery of visitor experiences, community engagement and commercial activities. Working with our National strategic teams and wider Operations Directorate you will be our expert in wisely using available resources to deliver exceptional standards of property care for now and for generations to come.

You'll work with the North Senior Team on regional planning working efficiently and flexibly with the resources available to you. Your plan will align with, and contribute to, the corporate strategic direction set by our the Operations Directorate. This will also deliver against the Asset Management Plan and supporting policies and deliver assurance on statutory compliance through inspections and reporting.

In conjunction with the Regional and District Works management, you will have a thorough understanding of the legislation, policies, processes, procedures and guidance related to the condition and care of our properties, working with colleagues across HES to make sure our properties are consistently safe, legally compliant, and professionally maintained environments.

Key responsibilities, duties and objectives

- Carry out on site condition surveys and annual conservation audits of the Properties in Care to establish future priorities and development work for district PICs and ancillary accommodation, including the compiling of conservation strategies and monument investment plans for the Properties in Care in conjunction with input from our specialist teams.
- Prepare work programmes, develop proposals and supporting contract documentation at all stages of the RIBA Work Plan, in conjunction with architectural technicians, quantity surveyors and other in-house specialist teams. Site works may be carried out by the Historic Environment Scotland monument conservation unit or external contractors.

- Deliver appropriate standards in conservation and project management in accordance with HES Conservation Principles and Standards and relevant regulatory requirements.
- Act as client representative, contract administrator or project manager as instructed. And in accordance with Historic Environment Scotland's management, financial, procurement and contract procedures.
- Inspect the quality of work on site and monitor expenditure against budgets in accordance with Historic Environment Scotland's financial procedures.
- Liaise with the HES Operations RVCM and DVCM, and Factor on matters of site presentation, staffing or factoring of properties in care.
- Compile and submit Scheduled Monument Consent, Planning Permission and Building Warrant applications where required for works or site operations as required.
- Act as the Principal Designer or designer for works in the region, where applicable and ensure Health and Safety is applied in everything we do.
- Support a strong sustainability ethos within the organisation, embedded in all projects from inception to completion and operation. Work with the HES Climate Change team to ensure compliance and help deliver the HES Carbon Management Plan 2017–2022, Scottish Government and Zero Waste Scotland Circular Economy strategy, Waste Scotland (Regulations) 2012 and HES Sustainability Policy.
- Ensure projects are compliant with relevant statutory regulations such as CDM regulations and support all internal HES policies, especially Equality Act 2010 and HES Access Policy.
- Assist with the developing digital CAFM (Computer Aided Facilities Management) system, and the new digital Properties in Care Asset Management System (PICAMS) that will link the data sets held within Conservation Directorate and HES.
- Provide data and information as required to the Estates Audit, Analytics and Reporting team to assist with the Annual PIC Conservation Report as required under the Scheme of Delegation.
- Provide professional and technical support, if required, to the statutory scheme
 of grant-aided repairs to listed buildings and scheduled monuments. This will
 involve site visits, preparation of advisory reports, review of proposals, and
 inspection of works to ensure appropriate standards are maintained. Caseload
 will be resource driven and duties may require travelling and overnight periods
 away from home.

- Working with HES colleagues in the development of major projects and the facilitation of wider corporate activity for district sites.
- Produce works packages responding to recommendations of FSRA, VSRA and H&S audits in liaison with responsible officers including design, specification and For Construction Package.
- Support DWM and DVCM on identifying appropriate resourcing asks across the district, including OPEX and IP bids.
- Act as a senior member of the regional operations team, supporting and leading on operational activity for HES within the region.
- Carry out Line Management Duties for BCT: Probation monitoring, Mid-Year and End Year Reviews.
- Support the regional Head of Operations on activities as and when required.

- You will be able to demonstrable experience of surveying historic buildings
